NOW THEREFORE BE IT RESOLVED that the General Code of the County of Oneida, as amended, through changes approved by the County Board of Supervisors through Resolution 144-80, dated December 15, 1980, and through changes necessitated by changes in State law as has been prepared by the revisor and as has been reviewed by the Resolutions and Ordinance Committee is determined to be an accurate representation of the General Code of Oneida County, Wisconsin, as has been amended and changed from time to time by the Oneida County Board of Supervisors through appropriate enactment of resolutions and ordinances through Resolution 144-80, dated December 15, 1980.

BE IT FURTHER RESOLVED THAT a copy of the General Code of Oneida County, Wisconsin, as amended, together with the changes and corrections which are set forth in the addendum attached hereto, be placed on file in the Office of the County Clerk for public inspection for not less than two weeks, and that notice thereof be given by the County Clerk in the legal newspaper for the County so that the same may be adopted by approval of an ordinance referring to the same at the August, 1981 meeting of the County Board.

ORDINANCE NO. 66-79

AN ORDINANCE TO CODIFY THE GENERAL ORDINANCES
OF ONEIDA COUNTY, WISCONSIN

WHEREAS, it is deemed expedient and necessary that the general ordinances of Oneida County be revised, codified and arranged in appropriate chapters, sections and subsections; that omissions be supplied, defects be amended and new ordinances be enacted; and that the same be published in book form to make the whole thereof plain, concise, intelligible and convenient; and

WHEREAS, the County Board authorized the preparation of a code of general ordinances for the County, which has been reviewed and approved by the Resolutions and Ordinances Committee, subject to minor changes which do not affect the intent or purpose of the code which have been explained to the Board; and

WHEREAS, a copy of such code has been on file and open for public inspection in the office of the County Clerk for not less than two weeks, as required by 66.035, Wis. Stats., and notice thereof was given by publication on July 28, 1979, in "The Rhinelander Daily News".

NOW, THEREFORE, BE IT RESOLVED:

Section 1. That the code of ordinances in book form entitled "General Code of Oneida County, Wisconsin", a copy of which is on file in the office of the County Clerk for public inspection, shall be and is hereby adopted as the general ordinances in and for Oneida County, Wisconsin.

Section 2. This ordinance shall take effect the day after passage and publication as provided by law.
