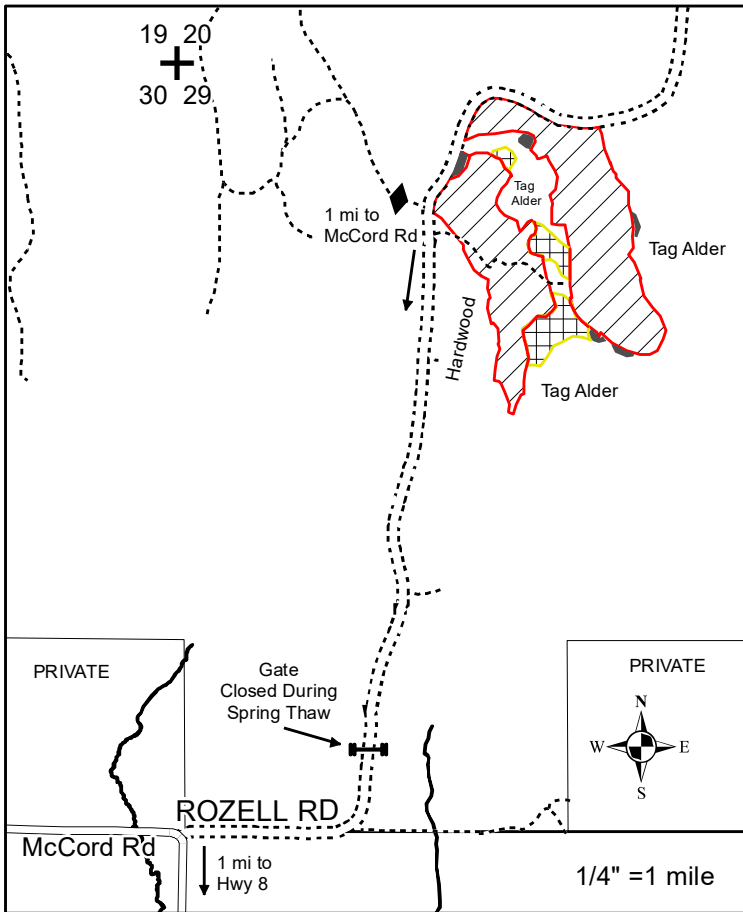

Additional Regulations:

- In the **Aspen Areas** harvest all 1" dbh (diameter at breast height) and larger aspen, white birch, ironwood, balsam fir, sugar maple, and red maple. Leave all cherry, yellow birch, elm, spruce, pine, oak and cedar. In the **Black Ash Areas Harvest only Black Ash 8 inches dbh and larger. No whole tree utilization in the Black Ash areas** Do not cut any other species. Utilization on all species is a 100" stick to a 4" top or whole tree. If harvesting whole tree, 1 in 10 tops above the standard 4" diameter must be left evenly scattered in the harvest areas. Standing dead trees are not to be cut unless they pose a safety hazard.
 - Logging operations, including road work, may take place only when the ground is sufficiently dry or frozen to prevent rutting. However, due to low, wet ground in the Black Ash and parts of the Aspen areas, frozen conditions will likely be required.
 - No equipment is allowed in the swampy, tag alder, wet-keg areas adjacent to or within the sale except when ground is frozen. Slash used for floatation while harvesting the Black Ash areas may remain in those areas if it comes from trees harvested there. If any slash is brought in for floatation in the Black Ash areas from upland sites, that slash must be removed to the extent possible.
 - All trails and landings must have approval of the County prior to construction. Following completion of the sale, all trails will be returned to their original condition or better. All access roads will be rocked or bermed off at the end of each harvest season and at the end of the sale. Bond money will not be returned until all road work is completed.
 - All slash must be cut to less than 2 ft high within 50 ft of Rozell Rd and must be pulled back 25 ft from the road. Decking on Rozell Rd may be allowed. Wood decked along the road must be far enough off the road so as not to create a hazard to motor vehicles. Skidding on Rozell Rd is only allowed when the road is dry or frozen. Any damage to the road will be repaired by the contractor including grading and graveling if necessary.
 - Rozell Rd is an ATV Route. Cautionary signs must be posted at McCord Rd and just east of the sale while sale is active.
 - Stump height may not exceed 10".
 - No harvesting within reserve areas. No equipment or slash will be allowed in these areas.
 - All items listed in the Oneida County Timber Sale Contract apply. All applicable BMP's will be followed.
