GENERAL CODE OF ONEIDA COUNTY, WISCONSIN

1 ORDINANCE OFFERED BY SUPERVISORS OF THE PLANNING & ZONING  
2 COMMITTEE.

3 WHEREAS, ordinance amendment #74-96 (zoning ordinance #477),  
4 which was approved by the County Board of Supervisors on September  
5 24, 1996; and ordinance amendment #15-97 (zoning ordinance #494),  
6 which was approved by the County Board of Supervisors on February  
7 18, 1997, amended the Oneida County Zoning and Shoreland Protection  
8 Ordinance as follows:

9 9.49 G Moratorium. For a period of 180 days beginning  
10 September 24, 1996, Oneida County officials shall not  
11 consider or grant a conditional use permit involving  
12 metallic mineral mining or prospecting unless prior to  
13 the 180 day expiration time period, the Oneida County  
14 Board of Supervisors have adopted a superseding ordinance  
15 involving metallic mineral mining and prospecting  
16 regulation with a majority of Towns approving or not  
17 objecting the same.

18 WHEREAS, during the months since the adoption of ordinance  
19 amendment #74-96 and #15-97, the Oneida County Planning and Zoning  
20 Committee met on several occasions to consider recommendations for  
21 revisions to sec. 9.49, Metallic Mineral Mining and Prospecting.

22 WHEREAS, the Committee and staff have recommended the existing  
23 sunset date of September 19, 1997 for sec. 9.49 G, Moratorium, of  
24 the Metallic Mineral Mining and Prospecting section of the County  
25 Zoning and Shoreland Protection Ordinance be extended an additional  
26 period of 180 days from September 19, 1997 so that the Committee  
27 and staff can review, consider and research the recommendations of  
28 the County's legal counsel and to develop amendments to the General  
29 Code of Oneida County, Wisconsin, including but not necessarily  
30 limited to amendments to sec. 9.49, Metallic Mineral Mining and  
31 Prospecting, that will then be considered at a public hearing
