UPDATES	<p>Communities Mobilizing for Change –Youth Leadership Institute, meeting attended by Jim and Bob.</p> <p>The emphasis is on community mobilization and environmental controls and uses the tobacco model. They recommend doing 100 on-on-one interviews, specific to alcohol as an assessment piece, with community members and to use these as a basis for expanding coalition. Must follow the process to be part of the program. Stresses advocating for policy level changes, ie keg registration, product placement issues, advertising and alcohol sponsorship of community events. Jim brought a DVD of teen Brain Scans, available through Jim at UW Extension. It shows scans of the brain during different exposures to alcohol.
