6 **WHEREAS**, the County Treasurer did request a reclassification of the Account  
7 Clerk I position in her office due to additional job duties and responsibilities being  
8 assigned to that position; and

10 **WHEREAS**, upon the review of the County Coordinator and the Labor Relations  
11 and Employee Services Committee, it was determined that the Account Clerk I position  
12 would be taking on additional duties and responsibilities that would necessitate a  
13 reclassification of that position; and

15 **WHEREAS**, based on the review by the Labor Relations and Employee  
16 Services Committee, it was determined that the proposed reclassification was  
17 appropriate based upon the changes to the Account Clerk I job description.

19 **NOW, THEREFORE, BE IT RESOLVED**, by the Oneida County Board of  
20 Supervisors that effective January 1, 2009 the Account Clerk I position shall be  
21 reclassified to a Deputy County Treasurer I position, Grade Level Six of the Courthouse  
22 Association Pay Plan.
