1 **Resolution offered by Supervisors of the Highway and Labor Relations Employee**  
2 **Services Committees.**

4 **Resolved by the Board of Supervisors of Oneida County, Wisconsin:**

6 **WHEREAS**, the current Oneida County Highway Commissioner, Nick Scholtes,  
7 is retiring on December 30, 2011; and

9 **WHEREAS**, by state statute the Oneida County Board of Supervisors has the  
10 authority to appoint a new Highway Commissioner upon the retirement of the incumbent  
11 Highway Commissioner; and

13 **WHEREAS**, by resolution #22-92 the Oneida County Board of Supervisors  
14 made the position of Oneida County Highway Commissioner one of indefinite  
15 appointment by the Oneida County Board of Supervisors; and

17 **WHEREAS**, the Highway and Labor Relations & Employee Services  
18 Committees recommends that, pursuant to Oneida County ordinance sec. 4.35,  
19 Promotions, Freeman Bennett, be promoted from the position of Patrol Superintendent  
20 to the position of Highway Commissioner at the time of the incumbent's retirement; and

22 **WHEREAS**, the Highway and Labor Relations & Employee Services  
23 Committees recommends that Grade level 16, Step 4, be the starting salary for  
24 Freeman Bennett upon his assumption of duties as the Oneida County Highway  
25 Commissioner.

27 **NOW, THEREFORE, BE IT RESOLVED**, that the Oneida County Board of  
28 Supervisors hereby appoints Freeman Bennett to the position of Oneida County  
29 Highway Commissioner effective upon the retirement of Nick Scholtes, the incumbent  
30 Highway Commissioner, on December 30, 2011.

32 **BE IT FURTHER RESOLVED** that the Oneida County Board of Supervisors  
33 approves the starting salary for Freeman Bennett as the Highway Commissioner to be  
34 Grade level 16, Step 4, at the time of his assumption of duties as the Highway  
35 Commissioner.
