

**RESOLUTION # 008-2012**

**Resolution offered by Supervisors of the Highway Committee.**

**Resolved by the Board of Supervisors of Oneida County, Wisconsin:**

**WHEREAS**, the Oneida County Highway Committee and Department seek to purchase one (1) Patrol Truck for snowplowing use in the winter months and maintenance use in the summertime; and

**WHEREAS**, the Highway Department has an account designated for the purchase of "Machinery" with \$325,000 available for 2012; and

**WHEREAS**, the Highway Committee has followed the proper bidding procedure in order to generate the lowest price for the Patrol Truck; and

**WHEREAS**, Oneida County Code sec. 3.09(2) requires County Board approval of purchases over \$100,000; and

**WHEREAS**, based upon the bidding procedure the total price for the new Patrol truck (complete with front plow, wing and underbody for snowplowing) is One Hundred thirty six thousand, five hundred and sixty-seven dollars and eleven cents (\$136,567.11); and

**WHEREAS**, the Highway Committee and Department have assessed their needs and determined that the purchase of this Patrol Truck is essential to the operation of the department and

**WHEREAS**, the Highway Committee and Department seek to use a portion of the available funds in the "Machinery" account to purchase the aforementioned Patrol Truck.

**NOW, THEREFORE, BE IT RESOLVED**, the Highway Committee and Department are authorized to purchase the Patrol Truck for the price of One Hundred thirty six thousand, five hundred and sixty-seven dollars and eleven cents (\$136,567.11); and

**BE IT FURTHER RESOLVED** that the Highway Committee and Department are authorized use the available funds in the "Machinery" account for the aforementioned purchase.
