RESOLUTION # 99-2012

Resolution offered by the Land Records Committee.

Resolved by the Board of Supervisors of Oneida County, Wisconsin:

WHEREAS, Oneida County retained a 100 foot strip of land on each side of the center line of existing roads crossing the Southeast ¼ - Northwest ¼ of Section 26, Township 36 North, Range 4 East, as recorded in Volume 64 of Deeds, Page 87, Document Number 104384, together with timber rights on said land, recorded in the Register of Deeds on March 29th, 1939; and,

WHEREAS, Thomas L Boyle and Debborah L Boyle, adjoining landowners to the above described strip of land submitted a request to Oneida County to purchase a portion of the 100 foot strip of land on Indian Village RD and has paid the \$500.00 administrative fee to process this request; and,

WHEREAS, the Town of Lynne has been notified of this request.

NOW, THEREFORE, BE IT RESOLVED, that the Oneida County Board of Supervisors hereby approves conveying the following described parcel of land and authorizes the County Clerk, upon receipt of the recording fee and land value of \$686.25, to issue a quit claim deed to the adjoining landowner as set forth below, conveying any interest the County has in the following description, provided the Town of Lynne does not have any objections to such conveyance.

To: Thomas L Boyle and Debborah L Boyle, Husband and Wife as survivorship marital property, 329 Roberts Dr, Mukowonago WI 53149.

That part of lands owned by Oneida County as retained in Volume 64 of deeds Page 87 being located in Southeast ¼ - Northwest ¼ (SE ¼-NW ¼) of Section 26, Township 36 North, Range 4 East that lies 33' west of the east line of said SE ¼-NW ¼ . Subject to easements, utilities or access of record or in use by others across said lands. This strip to be attached to lands in Document # 437233, parcel number LY 408.
