RESOLUTION # 100-2012

Resolution offered by the Land Records Committee.

Resolved by the Board of Supervisors of Oneida County, Wisconsin:

WHEREAS, Oneida County retained a 100 foot strip of land on each side of the center line of existing roads crossing Government Lot 4 of Section 16, Township 38 North, Range 8 East, as recorded in Volume 64 of Deeds, Page 37, Document Number 103215, together with timber rights on said land, recorded in the Register of Deeds on September 22, 1938; and,

WHEREAS, Brian R Waters, adjoining landowner to the above described strip of land submitted a request to Oneida County to purchase a portion of the 100 foot strip of land along Black Lake RD and has paid the \$500.00 administrative fee to process this request; and,

WHEREAS, the Town of Newbold has been notified of this request, which adjoins Black Lake RD.

NOW, THEREFORE, BE IT RESOLVED, that the Oneida County Board of Supervisors hereby approves conveying the following described parcel of land and authorizes the County Clerk, upon receipt of the recording fee and land value of \$517.50, to issue a quit claim deed to the adjoining landowner as set forth below, conveying any interest the County has in the following description, provided the Town of Newbold does not have any objections to such conveyance.

That part of lands owned by Oneida County as retained in Volume 64 of deeds Page 37 being located in Government Lot 4, Section 16, Township 38 North, Range 8 East that lies 33' east of the centerline of Black Lake RD. Subject to easements, utilities or access of record or in use by others across said lands. This strip to be attached to lands in Document # 703073, parcel number NE 626-1.
