6 Resolved by the Board of Supervisors of Oneida County, Wisconsin:

8 **WHEREAS**, the Labor Relations Employee Services Committee (hereinafter,
9 "Committee"), Corporation Counsel, Finance Director and Human Resource Director have met
10 with representatives of the Oneida County Non-Protective and Social Worker Union employees
11 bargaining units (hereinafter, "Union"); and

13 **WHEREAS**, the Committee and the Unions have reached a tentative agreement
14 concerning the contract for calendar year 2013; and

15
16 **WHEREAS**, the wage increase set forth below has been recommended by the
17 Committee; and

18
19 **WHEREAS**, the Oneida County Board of Supervisors have reviewed the proposed
20 changes for the purposes of ratification of the agreement between the Committee and the
21 Unions; and

23 **WHEREAS**, the Committee further recommends wage increases as set below for all
24 other general municipal employees.

26 **NOW, THEREFORE, BE IT RESOLVED**, that the Oneida County Board of Supervisors
27 does hereby ratify and approve the contract between the Committee and the Unions.

29 **BE IT FURTHER RESOLVED**, the Union's contract for 2013 shall incorporate the
30 following:

32 Non-Protected and Social Worker Union wage schedules shall include across the board
33 increase of 1% on January 5, 2013.
34 Wage schedules for all other general municipal employees shall include across the
35 board increase of 1% on January 5, 2013.
