

**RESOLUTION # 84-2013**

Resolution offered by the Land Records Committee.

**Resolved by the Board of Supervisors of Oneida County, Wisconsin:**

**WHEREAS**, Oneida County retained a 100 foot strip of land on each side of the center line of existing roads crossing the Southwest ¼ - Northwest ¼ of Section 22, Township 38 North, Range 8 East, as recorded in Volume 64 of Deeds, Page 463, Document Number 113205, together with timber rights on said land, recorded in the Register of Deeds on May 19<sup>th</sup>, 1942; and,

**WHEREAS**, Matthew Huston adjoining landowner to the above described strip of land submitted a request to Oneida County to purchase a portion of the 100 foot strip of land adjoining Muskellunge Lake RD and Ranch RD in the Town of Newbold and has paid the \$500.00 administrative fee to process this request; and,

**WHEREAS**, the Town of Newbold has been notified of this request.

**NOW, THEREFORE, BE IT RESOLVED**, that the Oneida County Board of Supervisors hereby approves conveying the following described parcel of land and authorizes the County Clerk, upon receipt of the recording fee of \$30.00 and land value of \$2,387.50, to issue a quit claim deed to the adjoining landowner as set forth below, conveying any interest the County has in the following description, provided the Town of Newbold does not have any objections to such conveyance.

That part of lands owned by Oneida County as retained in Volume 64 of deeds Page 463 being located in of the Southwest ¼ - Northwest ¼ of Section 22, Township 38 North, Range 8 East that lies 33' south of the existing traveled centerline of Ranch RD and 33' west of the existing traveled centerline of Muskellunge Lake RD. Subject to easements, utilities or access of record or in use by others across said lands. This strip to be attached to parcel number NE 700.
