3 GENERAL CODE OF ONEIDA COUNTY, WISCONSIN  
4 ORDINANCE AMENDMENT #

6 Ordinance Amendment offered by Forestry, Land and Recreation Committee  
7

8 WHEREAS, the Oneida County Forestry Department is responsible for the ongoing  
9 maintenance of County Forest Recreation areas, and

10 WHEREAS, there have been significant changes to several County Forest Recreation  
11 Areas in the past year, and

12 WHEREAS, existing regulations need to be adjusted to address these changes.  
13

14 NOW, THEREFORE, THE ONEIDA COUNTY BOARD OF SUPERVISORS DOES  
15 ORDAIN AS FOLLOWS:

16 Section 1. Any existing ordinances, codes, resolutions, or portions thereof in  
17 conflict with this ordinance shall be and hereby are repealed as far as any conflict exists.

18 Section 2. This ordinance shall take effect the day after passage and publication  
19 as required by law.

20 Section 3. If any claims, provisions or portions of this ordinance are adjudged  
21 unconstitutional or invalid by a court of competent jurisdiction, the  
22 remainder of this ordinance shall not be affected thereby.

23 Section 4. Section 14.07 (1) of the General Code of Oneida County, Wisconsin,  
24 is amended as follows [additions noted by underline, deletions noted by strikethrough]:

26 (e) Cutting or tapping trees prohibited. Cutting or removal of Christmas  
27 trees ~~or evergreen boughs~~ or the tapping of trees for sap collection is  
28 prohibited except as allowed under §14.07(a) (3) of this Code.  
29

30 (g) Balsam boughs may be collected upon purchasing a permit from the  
31 County Forest Office.

32 (h) No person may cut, root up, or gather wild ginseng located on county  
33 forest land.
