7                    **WHEREAS**, Section 66.1001 (4), Wisconsin Statutes, establishes the required  
8 procedure for a local government to adopt a Comprehensive Plan, and Section 66.1001(2)  
9 identifies the required elements of a Comprehensive Plan; and

11                    **WHEREAS**, the Comprehensive Planning Oversight Committee has the authority to  
12 recommend that the County Board of Supervisors adopt a "Comprehensive Plan" under Section  
13 66.1001(4)(b); and

15                    **WHEREAS**, the Comprehensive Planning Oversight Committee has prepared the  
16 attached County Comprehensive Plan document, containing all maps and other descriptive  
17 materials, to be the Comprehensive Plan for Oneida County under Section 66.1001, Wisconsin  
18 Statutes.

20                    **NOW, THEREFORE, BE IT RESOLVED**, that the Comprehensive Plan Oversight  
21 Committee of Oneida County hereby recommends adoption of the attached Comprehensive  
22 Plan as the County's Comprehensive Plan under Section 66.1001(4), Wisconsin Statutes; and

24                    **BE IT FURTHER RESOLVED**, that the Clerk certifies a copy of the attached  
25 Comprehensive Plan to the County Board of Supervisors for official adoption; and

27                    **BE IT FURTHER RESOLVED**, that the Comprehensive Plan Oversight Committee  
28 hereby recommends that, following a public hearing, and revisions to the Comprehensive Plan  
29 as needed, the County Board of Supervisors adopt an Ordinance to constitute official approval  
30 of the Oneida County Comprehensive Plan as the County's Comprehensive Plan under Section  
31 66.1001, Wisconsin Statutes.
